3. Pakistani National Identity card in original (with all previously held cards) in original OR an affidavit in lieu of duly notarized by the Notary Public and attested by the Pakistan Mission.
3. Original valid Pakistani Passport with all previously held Pakistani Passports.
4. Names of three close relatives/friends with their telephone numbers and complete
5. addresses in Pakistan who could provide information regarding your Pakistani citizenship.
6. \$150/- fee in shape of Money order or Cashier's cheque.
7. Five (5) latest photographs (coloured) with off white background.
8. Written and signed request with reason for renunciation of Citizenship.
9. The applicant will be apprised of the response when received from the concerned quarters.
10. No telephonic queries responded in this regard.
11. Incomplete applications will not be entertained.
